# Diocesan Council Meeting Diocese of the West Wednesday, October 14, 2009 Anderson Home, Santa Rosa, California

His Grace Bishop Benjamin convened the meeting of the Diocesan Council of the Diocese of the West at the Anderson home in Santa Rosa, California with the singing of "O Heavenly King".

## **Report of Bishop Benjamin:**

His Grace, Bishop Benjamin welcomed His Grace, Bishop Alejo to the 2009 Diocese of the West Assembly.

His Grace reported that the nuns at Santa Barbara in Santa Paula, CA have been living in RVs on the property. This is against the zoning laws and the nuns have been given 30 days to remove the RVs. The plan is for the nuns to move to the monastic community in Calistoga. Father Sergius Gerkins submitted a 'wish list' to Father Ian which will be reviewed by His Grace. The cost to build a chapel at Calistoga is approximately \$350K.

The Monastery Board will meet to discuss the sale of the Santa Paula property.

Father Matthew visited LGS. An attorney has been hired to represent us regarding the zoning issues. There has been much interest, but no offers.

Father David Lowell has been appointed Dean of the Denver Cathedral. He is at the Cathedral every other week during his transition from Raphael House.

His Grace received an email from Monk Stavros (?) expressing his desire to establish a new monastic community in the DOW. His Grace replied that the DOW has 5 monastic communities and that Monk Stavros can enter one of the existing monastic communities.

His Grace has been contacted by Bishop Andres of a non-canonical group who wishes to join the OCA. His Grace invited Bishop Andres to attend the Assembly tomorrow. Discussion followed.

#### **Report of the Treasurer:**

Mary presented the following action item for this meeting of the DOW Council: Signatories on the LCBA Mission Board Annuity Account need to be appointed.

**Motion:** Archpriest Ian MacKinnon moved, seconded by Mary Caetta, that the following members of the DOW be signatories on the LCBA Mission Board Annuity Account: His Grace, Bishop Benjamin, Archpriest Matthew Tate and Mary Caetta, Treasurer.

The Motion was unanimously approved.

The following motions were made in response to the Treasurer's Report:

**Motion:** Johann Morse moved, seconded by Priest Christopher Swanson, that Metropolitan Council Travel be increased by \$5000.00 to cover the expenses that are no longer paid by the National Church.

The Motion was unanimously approved.

**Motion:** Archpriest Anthony Karbo moved, seconded by Priest Michael Anderson, that Chancellor's Travel be increased by \$2000.00.

The Motion was unanimously approved.

**Motion:** Archpriest Anthony Karbo moved, seconded by Priest Christopher Swanson, that Traveling for Auditing Function be increased by \$4000.00. **The Motion was unanimously approved.**

    with these discussions.

**Motion:** Dorothy Nowik moved, seconded by Priest John Strickland to accept the updates to the Financial Policies and Accounting Procedures Manual. **The motion was unanimously approved.**

- **Budget:** Dorothy Nowik presented the proposed 2010 Budget Discussion followed. <u>Motion:</u> Johann Morse moves, seconded by Dmitri Solodow to increase travel for Diocesan Business to \$5000.00

Archpriest Ian MacKinnon suggested the stipend for the treasurer be increased by \$2000.00. Discussion followed. It is the consensus of the Council not to increase any salaries at this time.

**Motion:** Priest Michael Anderson moved, seconded by Dmitri Solodow to accept the modified budget to be presented at the Assembly. **The motion was unanimously approved.**
