## Diocesan Council Meeting Diocese of the West Tuesday, December 15, 2009 Bishop's Residence, San Francisco, CA

His Grace Bishop Benjamin convened the meeting of the Diocesan Council of the Diocese of the West with the singing of "O Heavenly King".

Minutes of the October 14 and 16 Meetings were accepted with corrections.

## **Report of Bishop Benjamin:**

His Grace reported that the 2011 All American Council will be held in Bellview, WA.

Archpriest John Pierce will chair the Pre-Conciliar Committee.

The Monastery Board approved the sale of the Santa Paula property for \$260K. Proceeds from the sale will be used to pay back the DOW loan.

His Grace will be traveling to Northern California in December, Mexico City and Guatemala in January and St. Petersburg in February.

Background checks have been completed for almost all clergy.

His Grace expressed his thanks to Fr. Ian and to Barry.

### **Report of the Treasurer:**

Mary presented the Treasurer's Report and spoke on the Summary Report. Mary also presented the formal housing allowances designations for Bishop Benjamin and Archpriest Matthew Tate adopted by the Council on October 16<sup>th</sup>. Discussion followed.

### **Old Business:**

## **Construction of Monastery Chapels:**

Additional invoices totaling \$10K were received.

**Motion:** Archpriest John Dresko moved, seconded by Dorothy Nowik, to authorize an additional \$30,000.00 to Santa Barbara from the Pt Reyes fund.

The motion was unanimously approved.

### **Diocesan Communications:**

- **2010 Diocesan Assembly Preparation** St. John's in Poway. The dates are October 19-21, 2010.
- **Charities:** Father Lawrence Russell spoke on the Gobezi Goshu Home.
- **Raphael Houses:** Father David will be retiring and a new director and chaplain will be needed. Bishop Benjamin appointed Archpriest John Dresko and Barry Migyanko to fill the two open positions on the Board. Both were approved by the Board.
- ➤ Parish & Clergy Screening/Background Checks: Background checks have been completed for almost all clergy. There are no incidents with anyone. There is 100% compliance with Youth Workers. Certification is required every year.
- ➤ **Diocesan Loan Program:** Peter Schwallenberg reported that the program has received Federal non-profit status. Fr. Stephen Soot is working actively on fund raising and 2 people on the Board of Trustees are bankers. A loan process will be presented in 2010. Discussion followed.
- ➤ LGS: The property is not sold. Fr. John Dresko is overlooking the property and Catherine Short is showing the property weekly. Both the tax and zoning issues are receiving legal attention.
  - *Motion:* Dorothy Nowik moved, seconded by Archpriest John Dresko to authorize spending a maximum of \$4288.00 out of the Pt Reyes Fund for LGS ongoing expenses for January through April 2010.

The motion was unanimously approved.

- Status of Diocesan Loans: Priest David Thatcher submitted a written report (attached) noting that the property tax exemption has been lost due to cessation of construction and they are delinquent for the first installment by over \$4000.00. Discussion followed. Archpriest Matthew Tate spoke on the Culver City Loan Application.
  Motion: Archpriest John Dresko moved, seconded by Priest John Strickland to loan the Culver City parish \$25,000.00 interest free for a period of six years. The first year loan payments would be forgiven with payments beginning at the end of the first year for a 60 month period beginning January, 2011.
  - The motion was unanimously approved.
- Audit Committee: Archpriest Michael Regan, Maha Estephan and Paul Pilipanko are the "Internal" Audit Committee members and will look at the policies and procedures being followed. An "External" Audit will be performed yearly.
- Metropolitan Council: Dmitri Solodow and Archpriest Matthew Tate reported on the latest meeting. Melanie Ringa is the new treasurer and is doing a very good job. Discussion followed. Fr. Matthew reported that his term on the Metropolitan Council will expire in October of 2010 and expressed his desire to remain on the MC which would require a change in the DOW Bylaws to extend the term of service on the Metropolitan Council. Discussion followed.
- **Diocesan Attorney:** Bishop Benjamin
- > Strategic Plan: Dmitri Solodow reported that the Metropolitan Council gave the committee four documents to consider and will meet with the Lesser Synod to discuss. Discussion followed. Bishop Benjamin appointed John Ericson and Archpriest David

Brum to prepare a "position paper" on the canonical relationship between Metropolitan and Bishops, and Bishops and Clergy to present at the next Diocesan Council Meeting.

### **New Business:**

- Diocesan Bylaws: Archpriest Basil Rhodes, Archpriest John Dresko and Dmitri Solodow are members of the Review Committee. Archpriest Basil Rhodes is the coordinator.
- Appeals: This year the Lenten charity appeal is for the Gobezi Goshu Home in Ethiopia. The Orthodox Stewards of the West appeal will go out during the Saints Peter and Paul fast.

2010 Housing Allowance Designation

The following resolution was duly adopted by the Diocesan Council of the Diocese of the West at their meeting held on October 16, 2009.

Whereas, ministers who own their home do not pay federal income taxes on the amount of their compensation that their employing church designates in advance as a housing allowance, to the extent that the allowance represents compensation for ministerial services, is used to pay housing expenses, and does not exceed the fair rental value of the home (furnished, plus utilities);

### And

Whereas, The Right Reverend BENJAMIN (Peterson) is compensated by The Diocese of the West exclusively for services as a "minister"; and

Whereas, The Diocese of the West does not provide The Right Reverend BENJAMIN (Peterson) with a parsonage; therefore, it is hereby

Resolved, that of the total annual compensation of \$68,000 paid to The Right Reverend BENJAMIN (Peterson) for the calendar year 2010, \$3,600 shall be designated as a housing allowance.
