**I. Executive Summary**

- Parish remittances are 42% of budget.
- Central Church Support from the Diocese of the West is 38% of budget.
- Stewards of the West income is 47% of budget.

**II. Statement of Financial Position (Accrual Basis - Consolidated Balance Sheet)**

The Consolidated Balance Sheet reflects both **unrestricted** and **restricted** fund accounts. Savings and investment account names on the detailed balance sheet report indicate the current interest rate on funds in those accounts. The following tables summarize the balances for operating and restricted funds as of April 2023, rounded to the nearest dollar.

### III. Operating P&L Year-to-Date, Actual versus Annual Budget

Net unrestricted income at the end of April was \$ 98,203.

The percent of budget for each major category should be between 30% and 40%. YTD Operating Income is 42% of budget and Operating Expenses are 31% of budget.

### IV. National Securities Investment Portfolio

National Securities funds are invested in short term bond funds and a money market account. The balance of the restricted cash is in a Wells Fargo savings account. **Unrealized** National Securities gain/loss as of the end of April is \$ (11,558).
