**I. Executive Summary**

- Parish remittances are 33% of budget.
- Central Church Support from the Diocese of the West is 33% of budget.
- Stewards of the West income is 33% of budget.

**II. Statement of Financial Position (Accrual Basis - Consolidated Balance Sheet)**

The Consolidated Balance Sheet reflects both **unrestricted** and **restricted** fund accounts. Savings and investment account names on the detailed balance sheet report indicate the current interest rate on funds in those accounts. The following tables summarize the balances for operating and restricted funds as of April 2024, rounded to the nearest dollar.

### III. Operating P&L Year-to-Date, Actual versus Annual Budget

Net unrestricted income at the end of February was \$ 35,857.

The percent of budget for each major category should be between 25% and 35%. YTD Operating Income is 33% of budget and Operating Expenses are 30% of budget.

### IV. National Securities Investment Portfolio

National Securities funds are invested in short term bond funds and a money market account. The balance of the restricted cash is in a Wells Fargo savings account.

**Unrealized** National Securities gain/loss as of the end of April is \$ 5,478.
