**I. Executive Summary**

- Parish remittances are 58% of budget.
- Central Church Support from the Diocese of the West is 55% of budget.
- Stewards of the West income is 38% of budget.

**II. Statement of Financial Position (Accrual Basis - Consolidated Balance Sheet)**

The Consolidated Balance Sheet reflects both **unrestricted** and **restricted** fund accounts. Savings and investment account names on the detailed balance sheet report indicate the current interest rate on funds in those accounts. The following tables summarize the balances for operating and restricted funds as of July 2024, rounded to the nearest dollar.

### III. Operating P&L Year-to-Date, Actual versus Annual Budget

Net unrestricted income at the end of July was \$ 51,842.

The percent of budget for each major category should be between 50% and 60%. YTD Operating Income is 58% of budget and Operating Expenses are 53% of budget.

### IV. National Securities Investment Portfolio

National Securities funds are invested in short term bond funds and a money market account. The balance of the restricted cash is in a Wells Fargo savings account.

**Unrealized** National Securities gain/loss as of the end of July is \$ 10,825.
