I. Executive Summary

- Parish remittances are 95% of budget.
- Central Church Support from the Diocese of the West is 71% of budget.
- Stewards of the West income is 81% of budget.

II. Statement of Financial Position (Accrual Basis - Consolidated Balance Sheet)

The Consolidated Balance Sheet reflects both **unrestricted** and **restricted** fund accounts. Savings and investment account names on the detailed balance sheet report indicate the current interest rate on funds in those accounts. The following tables summarize the balances for operating and restricted funds as of September 2025, rounded to the nearest dollar.

III. Operating P&L Year-to-Date, Actual versus Annual Budget

Net unrestricted income at the end of September was \$ 92,704.

The percent of budget for each major category should be between 80% and 90%. YTD Operating Income is 93% of budget and Operating Expenses are 87% of budget.

IV. National Securities Investment Portfolio

National Securities funds are invested in short term bond funds and a money market account. The balance of the restricted cash is in a Wells Fargo savings account.

Unrealized National Securities gain/loss as of the end of August is \$ 14,757.
